ORDER OF THE REVIEW COMMITTEE FOR DECLARATION OF WILFUL DEFAULTERS,
PURSUANT TO PROCEEDINGS CONDUCTED AT HEAD OFFICE ON 27.06.2022

M/s Kalika Enterprises (Rs.0.64 Crore)

In terms of RBI Master Circular no. DBR. No. CID.BC.22/20.16.003/2015-16 dated July, 01, 2015, Committee for Identification of wilful defaulters issued show cause notice dated 08.08.2020 to following firm/person mentioning the ground on the basis of which they were identified as wilful Defaulters:-

1. M/s Kalika Enterprises (Borrower)
2. Ms. Megha Kalra (Proprietor)

Vide show cause notice, the above named persons were given opportunity to make representation, if they so desire, to the Bank within 15 days from receipt of notice, as to why they be not classified as wilful defaulters. In spite of service of the said show cause notice(s), no reply/ representation was made by the above persons.

Thereafter, the Identification Committee after due consideration of the facts on record, in its meeting held on 29.05.2021 had observed that the above named persons had defaulted in payment/repayment obligations to the Bank and identified them as wilful defaulter on the following ground.

Siphoning of Funds

Sales proceeds were not routed through the account. The credit summations are only Rs.0.32 crore during 2013-2014.

Accordingly, the Identification Committee had issued order on 29.05.2021 In its said order, the committee had also directed that the above named borrower/proprietor are free to make a written representation against the order of Identification Committee, within a period of 15 days from the date of receipt of order to the Review Committee headed by the MD & CEO of the Bank.

Despite service of the order of the Committee for Identification of Wilful Defaulters of the Bank, no representation was received from the Borrower and the above named person, mentioned at serial nos.1 & 2.

ORDER OF THE REVIEW COMMITTEE FOR DECLARATION OF WILFUL DEFAULTERS:

The Review Committee chaired by the undersigned MD & CEO of the Bank and the Directors of the Bank as members, after due consideration of the above said facts and evidence on record, in its meeting held on 27.06.2022 concurred with the order of the identification committee and found that the captioned borrower/proprietor are responsible for the above event of wilful default, which constitute cogent ground of being declared as 'Wilful Defaulter' in terms of extant Bank guidelines issued in consonance with the RBI guidelines/Master Circular No. DBR. No. CID.BC.22/20.16.003/2015-16 dated 01.07.2015 and declared M/s Kalika Enterprises (Borrower) and its proprietor Ms. Megha Kalra as "Wilful Defaulter" for the reason mentioned above.
